Under the amended codes of good practice, if an entity is within the first 12 months of trading, or if their annual turnover is under R10 million per year, they are required to use an affidavit to declare their empowerment status.

The affidavit can be printed from the dti's website and stamped at a police station or by a commissioner of oaths, this is free of charge. Neither a SANAS accredited nor an IRBA registered BBBEE auditor may issue a BBBEE certificate for these entities, which qualify as exempt micro enterprises (EMEs).

If the entity's turnover is between R10 and R50million and they have at least 51% black ownership, they qualify as an "exempt" QSE, also via an affidavit.

The application of the amended codes and the basis for measurement are provided in Statement 000 of the Amended Code Series 000 Gazette No 36928 as amended by Gazette No 38765, and can be summarised as follows:
